Beginning *November 14th, 2024*, all subsequent **NOTICES** and communications delivered to the *Public Servant Fiduciary* TRUSTEES were sent using USPS Certificates of Mailing. This method, recognized as Lawful Presentment, establishes *verifiable proof that the parcel was deposited with the United States Postal Service for delivery*—a legally sufficient action in matters of controversy.

While Certificates of Mailing *do not confirm receipt* by the intended addressee, they do provide conclusive evidence that delivery was initiated, satisfying the requirement of **Lawful NOTICE** under administrative procedure.

Just as I extended an *Olive Branch* to David Scott Brown by offering a path to remove himself from the original COUNTERCLAIM of *September 27th, 2024*, I likewise extended a similar opportunity to ALL *Public Servant Fiduciary* TRUSTEES —providing them a clear and lawful means of **exoneration** from further involvement with this administrative action. This was in response to their ongoing failure to rebut, which matured into a **Bona Fide Obligation** within *My perfected Administrative Procedure*.

All communications issued after the occurrence of **Default** were directed **specifically to the individual party** who received the corresponding parcel. This marked a critical procedural transition in the administrative process: I was **no longer addressing the Public Servant Fiduciary** TRUSTEES as a **collective body**, but rather speaking to each one **individually**, in direct relation to **their personal accountability** and **official role within the societal and governmental structure** of the community of Snyder, Texas.

This individualized approach renders all subsequent documentation **even more precise and enforceable**, as each communication was tailored to the **particular acts, omissions, and public duty** of the named fiduciary, further affirming the **personal obligation** incurred by each due to their failure to rebut or cure the perfected record of claim.

There were **two specific - individually addressed communications** delivered to each party—one on *December 16th, 2024*, and the **final** being **deposited with the United States Postal Service** on *January 10th, 2025*. And for the benefit of order the following Certificates of Mailing are for the December 18th 2024, conveyed Presentment to the *Public Servant Fiduciary* TRUSTEES which were ALL Conveyed to the recipients' HOME Address for the purpose of allowing them each to realize this is a personal obligation and NOT tied to their individual employment with the CITY OF SNYDER, INC.

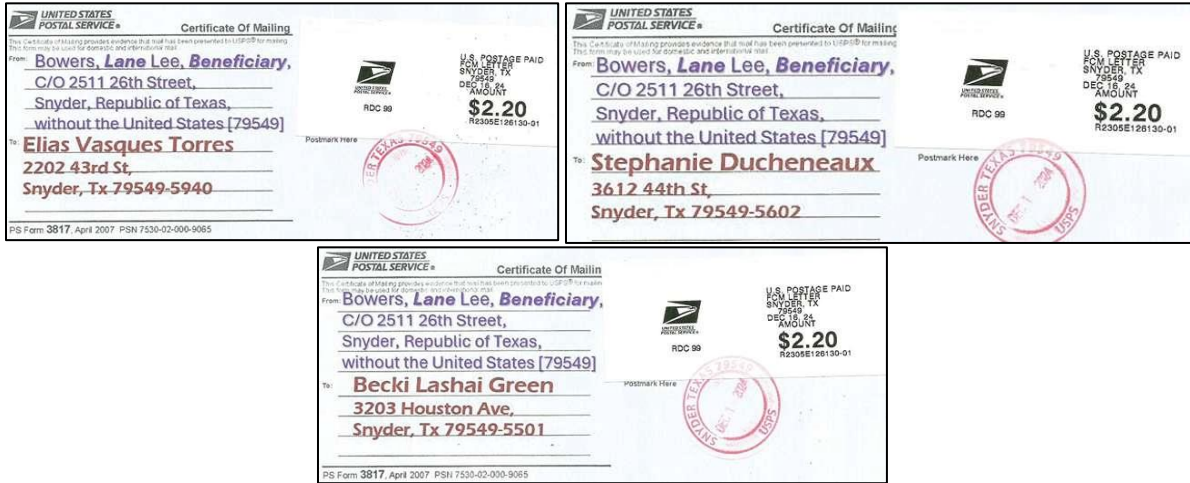

However, preceding these letters is the introductory section of a dedicated online web page created for each respective party. This initial content is identical across all recipients, serving as a formal contextual preface. Following that uniform introduction, each page transitions into party-specific instructions outlining the precise steps each individual must take in order to exonerate themselves from the obligation that was lawfully established through My perfected Administrative Procedure.

Said obligations were created by their individual and collective failure to rebut, resulting in acquiescence and tacit agreement to the terms, conditions, and liabilities defined therein.

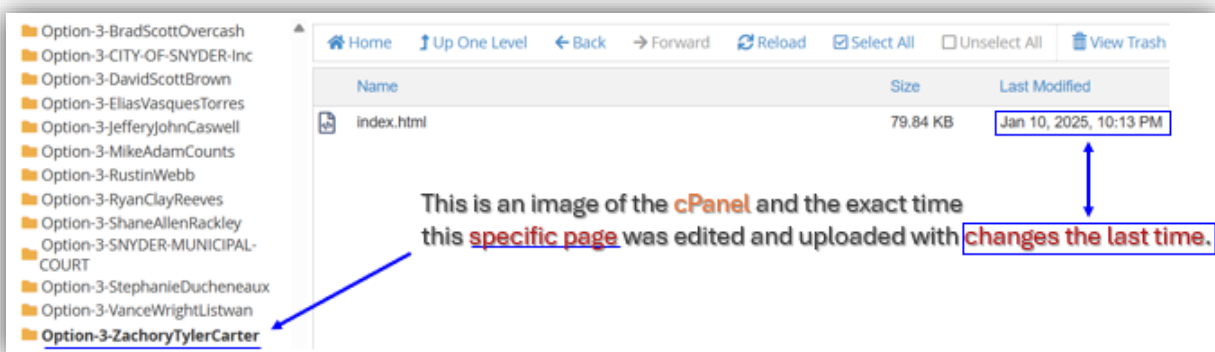
As evidenced throughout the documentation of this Administrative Procedure, the content I have presented is delivered with emphasis and clarity, utilizing bolding, italics, underlining, and color-enhanced text to distinguish critical elements. 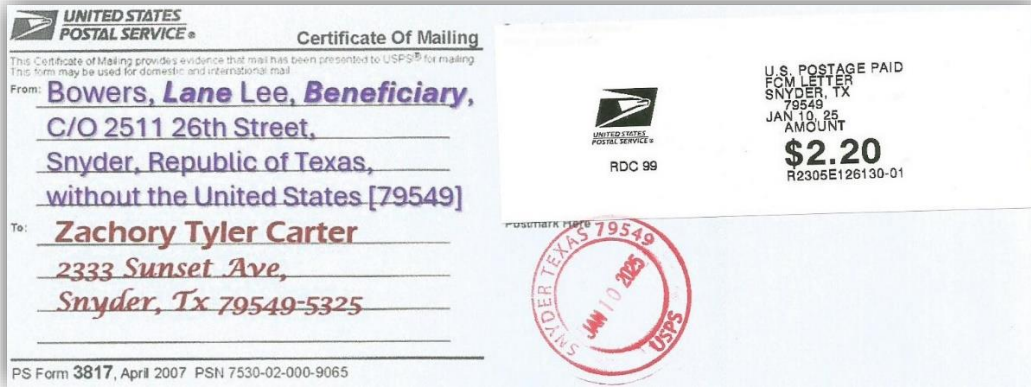
