PART 3 is the Chronological Evidence of CITY OF SNYDER, INC. *Public Officials*, employees and *Insurer*, Texas MUNICIPAL League Intergovernmental Risk Pool and Principals, *unlawfully withholding Public BOND Information* from an Injured Party, while *Willfully* and *Knowingly*, Violating the Texas Public Information Act, (TPIA) known as Texas Open Records Act.

The information conveyed in this document, individual specific communications, **NOTICES**, Presentments are Authentic, Verifiable by USPS Certified and REGISTERED Mail numbers as well as online server time stamped documentation of when said documents were created and conveyed to the Public Servant Fiduciary TRUSTEES all of which was Lawfully Conveyed in Good Faith and Honor.

The Texas PIA was initially known as the *Texas Open Records Act* and was approved by the state legislature in 1973. The statutes of the TPIA are codified in *Chapter 552 of the Texas Government Code*. The TPIA is the basis of the government's policy for open government in the state. The Act aims to keep the government accountable to its people and improve the public's participation in government.

For the purpose of this record, the Texas Public Information Act (TPIA), formerly known as the Texas Open Records Act, shall be referred to as TPIA.

This PUBLISHED Texas Law is *required to be adhered to by every city, municipality, political subdivision, state agency without question*.

FIRST REQUEST AND DENIAL September 11th, 2024:

On-site verbal request for bonding and insurance information ~ denied.

As the officers we're preparing to *unlawfully* take My PRIVATE Property, I asked all of them for their business card, as I know their business cards are required by STATE OF TEXAS law, their regulations, policies, and procedures are to have their *insurance providers name*, and *business address* along with the *Public Servants BOND Identification Number*. Upon this request, they admittedly said that the city police department hadn't provided them with business cards and all the information I needed was going to be on the citation. That's a lie, there is no BONDING or Surety information on the citation. This request was made in compliance with state law, which mandates that public servants provide bond and liability information upon request. Each officer present failed to produce bond information as required by law, thereby abdicating their fiduciary obligation to provide access to public records, in clear contravention of Texas Government Code § 552. Their failure to do so constitutes a violation of the Texas Public Information Act and public trust. *This was My First Request for Bonding Information* as it is required by law that public servants provide their *Bonding Information* immediately when it is requested of them.

Throughout the *Administrative Procedure* I unambiguously pointed out that *Public Servants Fiduciary TRUSTEES* are by law, supposed to provide anyone who asked them “Specifically” for their BOND information, and *to provide that information immediately upon request*. Throughout this process in the documents delivered to all *Public Servants Fiduciary TRUSTEES*, I specifically made this FACT *crystal clear* as is evidenced by and in the *September 27th, 2024*, *NOTICE* of COUNTERCLAIM ~ Citation #E020937 ~ An Averment of Lawful Principle, on the 16th page of that presentment, from the middle of the page to the bottom, the following was intentionally and specifically conveyed:

This *NOTICE* contains specific articulation of published law identifying the valid, verifiable proof of injury to Lane, the party asserting this claim, levying a FIXED FEE, a *Sum Certain* of coinage in .99999 pure Troy Ounce of Silver against public officials and principle for having sustained injury at the hand of his public servant officials. It is required of you to make available to charges those injured and/or harmed by providing your insurance carrier(s) that provide your public ‘official’ BOND(s) of insurance, you are demanded to provide BOND information when responding to this Common Law Contract and *Administrative Process* ---- *NOTICE* of COUNTERCLAIM ~ Citation #E020937 ~ Lawful Just Averment.”

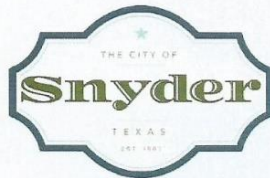

Be It Known: This FOIA Request, bearing the Certified Mail # **9589 0710 5270 2118 2205 68** establishes a Common Law contract in accord with the Postal Rule, which states the following:

"The postal rule (also known as the mailbox rule or "deposited acceptance rule") is a term of common law-contracts which determines the timing of acceptance of an offer when mail is contemplated as the medium of acceptance. The general principle is that a contract is formed when acceptance is actually communicated to the offeror. The mailbox rule is an exception to the general principle. The mailbox rule provides that the contract is formed when a properly pre-paid and properly addressed letter of acceptance is posted. One rationale given for the rule is that the offeror nominates the post office as implied agent and thus receipt of the acceptance by the post office is regarded as that of the offeree. The main effect of the mailbox rule is that the risk of acceptance being delivered late or lost in the post is placed upon the offeror. If the offeror is reluctant to accept this risk, he can always require actual receipt before being legally bound."

This contract, an agreement of parties to it is binding once signed for, accepted, received by them, their agents, employees, and/or mail room personnel and/or any other person of their company, corporation, entity, which, evidences the existence of **A Duty to Perform** by law, under and in accord to this FOIA Request.

LOCAL GOVERNMENT CODE TITLE 11. PUBLIC SAFETY SUBTITLE A. MUNICIPAL PUBLIC SAFETY, CHAPTER 341. MUNICIPAL LAW ENFORCEMENT, SUBCHAPTER A. REGULAR POLICE FORCE: Sec. 341.001.

(d) **Each police officer shall execute a bond as the GOVERNING BODY may require.** The bond must be conditioned that the officer will faithfully perform the officer's duties.

This code means that the **CITY OF SNYDER, Inc.** **MUST** within its corporate structure follow what the **STATE OF TEXAS, Inc.** laid out for municipalities, cities, and **political subdivisions** of TEXAS. This Texas law clearly states that someone within the corporate structure of **CITY OF SNYDER, Inc.** has the information I requested within the initial FOIA Request, Certified Mail Number: **9589 0710 5270 2118 2143 69** and now this 2nd FOIA Request, Certified Mail Number: **9589 0710 5270 2118 2205 68**.

So, **TRUSTEES**, your OFFICE will either follow the law or you all three will be accountable and charged under it, makes no difference to me, because withholding information that you know you have access to and as a Fiduciary to the Public Trust having a Duty to provide Requested information is fraud when you tell me to seek it elsewhere. Beyond fraud, there's malfeasance of Public OFFICE by your willful and intentional actions of wrongdoing by a public official. Bearing BOTH civil and Criminal penalties that you as **TRUSTEES** to the Public Trust may by law be charged, resulting in BOTH monetary and jail time.
