EXECUTIVE SUMMARY:

This sworn instrument is an Evidentiary Chronological Record, fully authored and executed by Lane Lee Bowers©, acting as Trustee of the Sojourn Bequest Irrevocable Trust (SBIT) for and on behalf of the Sundual Reparations Irrevocable Trust (SRIT). It presents a detailed and verifiable account of **public obstruction, fiduciary breach, and commercial dishonor**—culminating in the willful refusal to record a lawfully bonded, perfected commercial lien obligation despite proper **NOTICE** and presentment.

Due to prior dealings and a clear understanding of the modern corporate-state hybrid operating under the guise of civil government, I anticipated the resistance documented herein. While these officials—elected or appointed—may occupy real offices, they often act in ignorance of what is **lawful**, substituting it for what is merely **procedural** or **policy-bound** and/or simply protecting others who they **personally know**.

This **Part 5** Record confirms that on **December 6, 2024**, I lawfully deposited **NOTICE** to the Scurry County Clerk, anticipating obstruction and establishing a preemptive **contractual and administrative framework**. That Notice was designed to prevent bureaucratic delay and secure timely performance of a nondiscretionary duty. When the Recordation was unlawfully denied, followed by **false accusations of fraud**, the Clerk and associated actors triggered estoppel, default, and a public trust breach under color of law.

This instrument stands as a **self-authenticating, bonded commercial record**, supported by USPS tracking, presentment evidence, sworn affidavits, and lawful declarations under penalty of perjury. It is certified and enforceable for judicial notice, fiduciary enforcement, or commercial securitization in accordance with constitutional law, trust principles, and the Uniform Commercial Code.

Be It Known: This **NOTICE** establishes a Common Law contract under the Postal Rule, which states:

"The postal rule (also known as the mailbox rule or "deposited acceptance rule") is a term of common law-contracts which determines the timing of acceptance of an offer when mail is contemplated as the medium of acceptance. The general principle is that a contract is formed when acceptance is actually communicated to the offeror. The mailbox rule is an exception to the general principle. The mailbox rule provides that the contract is formed when a properly pre-paid and properly addressed letter of acceptance is posted. One rationale given for the rule is that the offeror nominates the post office as implied agent and thus receipt of the acceptance by the post office is regarded as that of the offeree. The main effect of the mailbox rule is that the risk of acceptance being delivered late or lost in the post is placed upon the offeror. If the offeror is reluctant to accept this risk, he can always require actual receipt before being legally bound."

The agreement/contract is binding on all parties once signed for/accepted/received by them, their agents, employees, and/or mail room personnel and/or any other person of their company, corporation, entity, which evidences the existence of **A Duty to Perform** under and according to law this **NOTICE** provides.

The moment the County Clerk receives any document, it is recorded according to **published law**.

• • • ATTENTION SCURRY COUNTY RECORDS OFFICE • • •

Federal Rules of Civil Procedures 5 (d) (4) - Acceptance by the clerk.

A clerk must not refuse to file a paper solely because it is not in the form prescribed by these rules or by a local rule or practice.

18 U.S. Code § 2071 - Concealment, removal, or mutilation generally

(a) Whoever willfully and unlawfully conceals, removes, mutilates, Obliterates, or destroys, or attempts to do so, or, with intent to do so takes and carries away any record, proceedings, map, book, paper, document, or other thing, filed or deposited with any clerk or officer of any court of the United States, or in any public office, or with any judicial or public officer of the United States, shall be fined under this title or imprisoned not more than three (3) years, or both;

(b) Whoever, having the custody of any such record, proceedings, map, book, document, paper, or other thing, willfully and unlawfully conceals, removes, mutilates, obliterates, falsifies, or destroys the same, shall be fined under this title or imprisoned not more than three (3) years or both; and shall forfeit his/her office and be disqualified from holding any office under the United States...

For each instrument/document a CUSTODIAN OF RECORDS agent, County clerk or clerk of the courts refusal to Record on and for the Record is by this NOTICE being made aware of the consequences of their willful and intentional criminal actions against their Duty to the Public and their Voluntary Oath to their OFFICE of Trust.

For NON-acceptance and/or refusal to make a record in Scurry County Records Books for any of my documents will result in a FIXED FEE of 2,000.00 Two Thousand USD in 'SD' per page, per instance charged to you personally and your office for such act of refusal to follow the written law, individually and severally.

Notice Beyond the Above Stated Published Law

Then there is Lane's Law concerning making a Record of ANY document: When the COUNTY RECORDS OFFICE receives ANY Affidavit or Document, even if it is written on a napkin or an inscribed NOTICE presented to the COUNTY'S CUSTODIAN OF RECORDS given on an animal hide, the Document Presented is by law recorded.

First you should understand that the Office of Scurry County Records is the Public's Office which you and your staff receive paychecks for performing the Duties, as the County's Custodians of Records, NO Matter what the source or what the documents contents are. It is NOT an instrumentality of government structure with license to pick and choose what is and isn't to be recorded. You are duty bound by said OFFICE to make the Public Record of such documents, affidavits, and/or instruments, for the benefit of the Public Good.

As the Scurry County's Custodian of Records should you refuse to acknowledge, accept, recognize and/or record any document deposited in 'Good Faith' with your OFFICE; Scurry County Records you and your office will at that moment willfully and intentionally committed a crime against justice under Statutes at Large Sec. 5403 punishable by up to a \$2,000 fine and 3 years imprisonment, which I will see to it that you answer for.

NOTICE just so you know what jeopardy you will be putting your livelihood and those of your OFFICE in by NOT Recording ANY Document I Deposit with Scurry County’s Custodian of Records OFFICE.

All my contracts, what you are now reading as well, are self-executing by nature, this one is between you, *Melody Appleton* and Myself, Bowers, Lane Lee, *Beneficiary*, a contract requiring you and your office to do what you are being paid for, make a record of the documents that are presented without an opinion of the documents merit.

However, by NOT discharging your duty as the Scurry County’s Custodian of Records, by your NON-Action you leave me no choice but to either charge or add the OFFICE of Scurry County’s Custodian of Records and you personally for dereliction of your Duty, as you continue to accept compensation for making a record for the benefit of the Public Trust and the People of the Snyder and Scurry County community.

For EXAMPLE: If I convey a **Claim of Lien / Affidavit of Obligation** for Recordation, and you do not perform your duty by recording the instrument on and for the record, you will be added as a libellant to the **Claim of Lien / Affidavit of Obligation** intended to be recorded with the County’s Custodian of Records OFFICE which I promise is well above and beyond what Statutes at Large Sec. 5403 provides for punishment for NOT Performing your Duty.

Upon your refusal to Record ANY Document or Affidavit I present I will immediately report your dereliction of Public Duty to the State Attorney General’s Office and the United States DOJ Attorney General’s Office. Then I will **BILL** the Scurry County Custodian of Records **OFFICE for non-service**, as well as you personally, *Melody* as the **OFFICE HOLDER** in your personal capacity a **FIXED FEE** of 2,000.00 USD in ‘SD’ per page that you refused to make record of on Scurry County’s Records Books. ----- See: TinyURL.com/ZERO-Immunity

Published Law is Quite Clear...

Title LXX.--CRIMES.-- CH. 4. CRIMES AGAINST JUSTICE

(Destroying, &c., public records.)

SEC. 5403. Every person who willfully destroys or attempts to destroy, or, with intent to steal or destroy, takes and carries away any record, paper, or proceeding of a court of justice, filed or deposited with any clerk or officer of such court, or any paper, or document, or record filed or deposited in any public office, or with any judicial or public officer, shall, without reference to the value of the record, paper, document, or proceeding so taken, pay a fine of not more than two thousand dollars, or suffer imprisonment, at hard labor, not more than three years, or both: [See § § 5408, 5411, 5412.1]

(Conspiracy to defeat enforcement of the laws.)

SEC. 5407. If two or more persons in any State or Territory *conspire for the purpose of impeding, hindering, obstructing, or defeating, in any manner, the due course of justice in any State or Territory, with intent to deny to any citizen the equal protection of the laws, or to injure him or his property for lawfully enforcing, or attempting to enforce, the right of any person, or class of persons, to the equal protection of the laws*, each of such persons shall be punished by a fine of not less than five hundred nor more than five thousand dollars, or by imprisonment, with or without hard labor, not less than six months nor more than six years, or by both such fine and imprisonment. See § § 1977-1991, 20042010, 5506-5510.1

(Destroying record by officer in charge.)

SEC. 5408. *Every officer, having the custody of any record, document, paper, or proceeding specified in section fifty-four hundred and three, who fraudulently takes away, or withdraws, or destroys any such record, document, paper, or proceeding filed in his office or deposited with him or in his custody*, shall pay a fine of not more than two thousand dollars, or suffer imprisonment at hard labor not more than three years, or both-, and shall, moreover, forfeit his office and be forever afterward disqualified from holding any office under the Government of the United States.

Crime - Obstruction of Justice

The federal and state governments also prosecute offenders for the crime of obstructing justice. Crimes in this area usually involve *the offender taking some affirmative action to interfere with or prevent law enforcement or government actors from carrying out their duties*.

The crime of obstructing justice may include any of the following acts designed to prevent the discovery, arrest, prosecution, conviction, or punishment of a specific crime by another person:

- ~~Harbor or conceal the person who committed the crime~~
- ~~Warn the person who committed the crime of discovery or arrest~~
- *Destroy or conceal evidence of the crime*
- ~~Provide the person who committed the crime with the means to avoid discovery or arrest~~
- ~~Provide false information to assist the person who committed the crime~~
- *Prevent or obstruct someone from doing some act that will lead to the discovery or arrest of the person who committed the crime*

Often, obstruction of justice will be a felony if the underlying crime is also a felony. It will be a misdemeanor if the underlying crime is a misdemeanor.

Tampering With Evidence

The related crime of tampering with evidence also exists at the federal and state levels. Tampering with evidence is generally a felony offense. It does not require a verbal statement. The focus of a tampering charge is the offender's conduct. The law prohibits conduct that seeks *to hide, conceal, alter, or destroy evidence with an intent to prevent or damage its use in a criminal investigation or proceeding*.

18 U.S. Code § 1505 - Obstruction of proceedings before departments, agencies, and committees

Whoever, with intent to avoid, evade, prevent, or obstruct compliance, in whole or in part, with any civil investigative demand duly and properly made under the Antitrust Civil Process Act, *willfully withholds, misrepresents, removes from any place, conceals, covers up, destroys, mutilates, alters, or by other means falsifies any documentary material*, answers to written interrogatories, or oral testimony, which is the subject of such demand; or attempts to do so or solicits another to do so; or...

Shall be fined under this title, imprisoned not more than 5 years or, if the offense involves international or domestic terrorism (as defined in section 2331), imprisoned not more than 8 years, or both.

Shall be fined under this title or imprisoned not more than five years, or both.

And there are plenty of charges that can be realized from **18 U.S. Code § 1512 - Tampering with a witness, victim, or an informant ...**

It is settled law that delivery of a pleading to a proper official is sufficient to constitute filing thereof. *United States v. Lombardo*, 241 U.S. 73, 36 S. Ct. 508, 60 L. Ed. 897 (1916); *Milton v. United States*, 105 F.2d 253, 255 (5th Cir. 1939).

In *Greeson v. Sherman*, 265 F. Supp. 340 (D.C.Va. 1967), it was held that a pleading delivered to a deputy clerk at his home at night was thereby filed. [*Freeman v. Giacomo Costa Fu Adrea*, 282 F. Supp. 525 (E.D.Pa. 1968)]

"An instrument is deemed in law filed at the time it is delivered to the clerk, regardless of whether the instrument is title-marked. *Biffle v. Morton Rubber Indus., Inc.*, 785 S.W.2d 143, 144 (Tex.1990).

So, *Melody Appleton* it boils down to one thing. perform your Duty Lawfully according to the Law of the Land by making a Record of/for ANY Document I introduce to your OFFICE and there will be NO Issue.

The preceding **eight (8) pages** were prepared specifically to notify **Melody Ann Appleton**, Scurry County Clerk, in advance that I would be presenting documents for **public recordation**. I made clear that the subject of my presentment would be a **Claim of Lien / Affidavit of Obligation**.

Within that initial **NOTICE**, in the **third and fourth full paragraphs**, I intentionally and expressly stated the following:

“However, by NOT discharging your duty as the Scurry County’s Custodian of Records, by your NON-Action you leave me no choice but to either charge or add the OFFICE of Scurry County’s Custodian of Records and you personally for dereliction of your Duty, as you continue to accept compensation for making a record for the benefit of the Public Trust and the People of the Snyder and Scurry County community.

*For EXAMPLE: If I convey a **Claim of Lien / Affidavit of Obligation** for Recordation, and you do not perform your duty by recording the instrument on and for the record, you will be added as a libellant to the **Claim of Lien / Affidavit of Obligation** intended to be recorded with the County’s Custodian of Records OFFICE which I promise is well above and beyond what Statutes at Large Sec. 5403 provides for punishment for NOT Performing your Duty.”*

Keep this statement in mind as you review the details that follow, for it provides the **context and foresight** with which I approached this encounter. As will be shown, **Melody Ann Appleton’s conduct confirmed** my expectations about the resistance I would face when presenting a lawful claim that exists **outside the comfort zone** of ordinary bureaucratic procedure.

On **February 14th, 2025**, I finalized all supporting documentation of the chronological events and tendered to the **Scurry County Records Office** My **Claim of Lien / Affidavit of Obligation** for recordation. I had also prepared **two additional documents** for recordation. I presented all three simultaneously.

Of the three, **only one document** was accepted and recorded. The remaining two—(1) the **Claim of Lien / Affidavit of Obligation**, and (2) the **LANE LEE BOWERS© CESTUI QUE TRUST**, originally recorded in Davidson County, Tennessee—were **rejected**.

The Trust document was not notarized in Texas, and while I understood her position on that technical point, my intent was merely to **place the trust on record for public notice purposes**, not to re-establish its origin. Nonetheless, I deferred the Trust matter until such time as Texas notarization could be obtained.

The rejection of the **Claim of Lien / Affidavit of Obligation**, however, was met with a **completely different and unjustified excuse**. Clerk Appleton asserted—*without lawful authority*—that “*the office does not record such documents, an assertion wholly unsupported by any governing statute or oath-bound obligation.*” I immediately rebutted her assertion, reminding her that **banks, real estate entities, and the IRS** routinely file liens and similar instruments for recordation without issue.

She then stated she would **leave a copy with the County Judge and Attorney for review**, claiming she did not want to “break the law.” I responded directly:

“You are breaking the law right now by refusing to record My presentment.”

I then exited the office.

Six days later, **February 20th, 2025**, I received an official response letter from **Melody Ann Appleton**, in which she declared that the document appeared to be a “**fraudulent conveyance.**”

Following herein is that letter and immediately following **Melody’s Letter** is My response to this accusation with verifiable proof that the conveyance is **NOT Fraudulent - Melody’s 2nd NOTICE** and Opportunity to perform Her lawful ministerial duty as the County Clerk.

According to Govt. Code 50.901

(d) If a county clerk believes in good faith that a document filed with the county clerk to create a lien is fraudulent, the clerk SHALL:

- (1) request assistance of the county or district attorney to determine whether the document is fraudulent before filing or recording the document;
- (2) request that the prospective filer provide to the county clerk additional documentation supporting the existence of the lien, such as a contract or other document that contains the alleged debtor or obligor’s signature; and
- (3) forward any additional documentation received to the county or district attorney.

Mr. Bowers,

Pursuant to (d) (2) and after speaking to the county attorney, I am requesting that you provide me with the documentation listed before I may consider filing the liens.

Additionally, the county attorney advised the document does not appear to be a proper lien pursuant to Texas or Federal statute and that same will not be filed at this time. If you can find the documentation and provide it is, we will review. Otherwise, the county attorneys’ opinion is this is a fraudulent filing under this section and the penal code.

DISCUSSION

- Breach of Fiduciary Duty:** As a public fiduciary, the clerk holds a duty to lawfully serve all constituents. Refusal to record without lawful justification constitutes breach of trust.
- RICO Exposure — Racketeer Influenced and Corrupt Organizations Act:** When suppression of lawful documents is executed through repeated, collusive action involving other public officers, it constitutes a pattern of enterprise-based obstruction qualifying as racketeering activity under federal law.

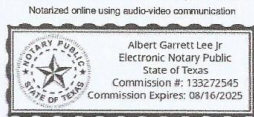

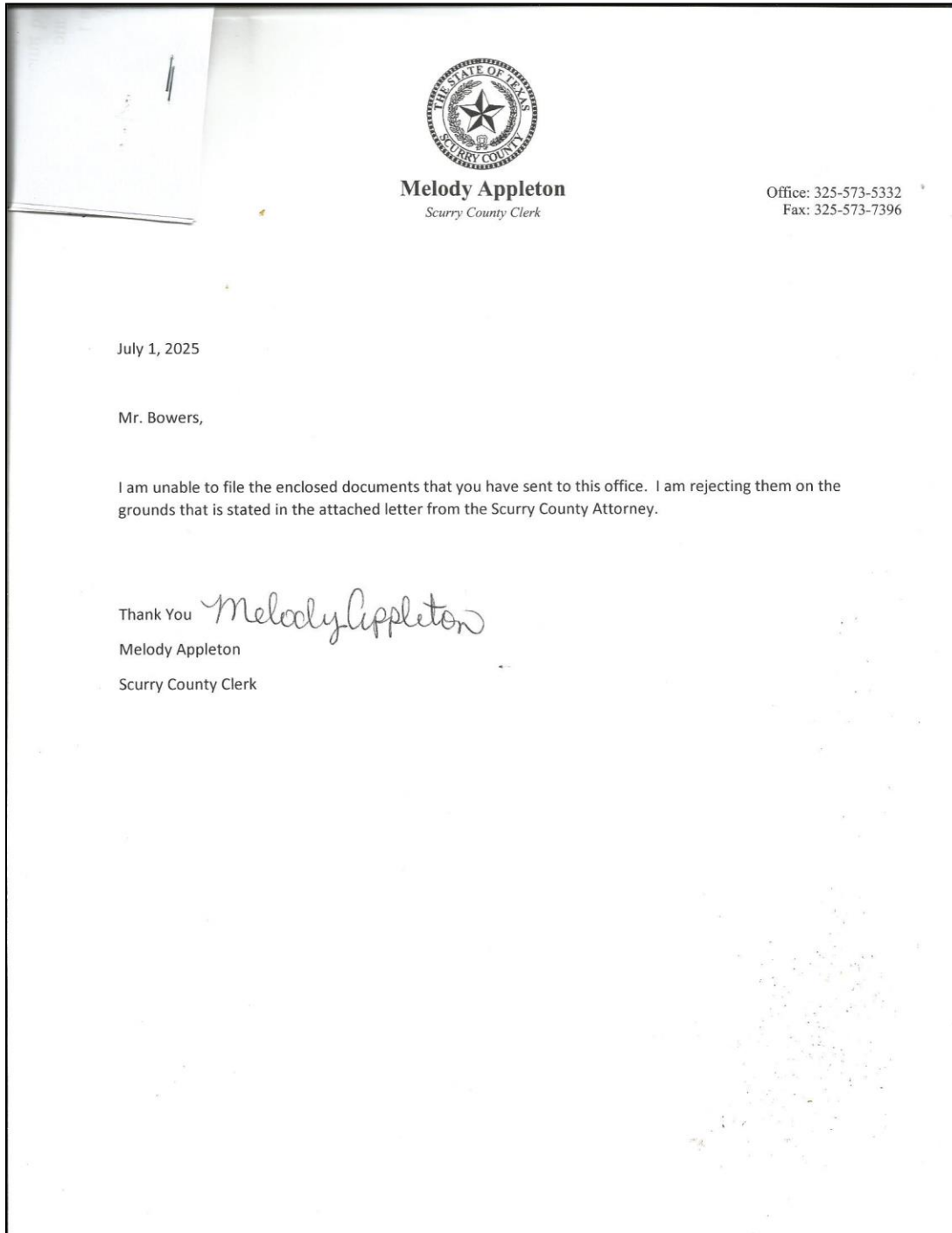

Dear Mrs. Appleton:

I am in receipt of a copy of the packet you received from Lane Lee Bowers (Trustee) for filing in the Official Records of your office on or about June 27, 2025.

The documents provided seem to attempt to create a lien on various individuals and/or entities located in Scurry County, Texas and further reference a Default Judgement that does not appear to be based on, or from, any competent court of Jurisdiction for the State of Texas or any other State. Further, the proposed "Entry of Default Judgement", "Affidavit of Obligation/Claim of Lien" included in said packet appear to be baseless, not grounded in any cognizable law, ordinance, or regulation recognized by any duly existing court of competent jurisdiction in the State of Texas or any other State in the United States of America. Additionally, nothing contained in the packet provided satisfies the requirements of Texas Government Code 51.09 and the sections contained therein. It appears the proposed documents(s) attempt to create a lien or purport to be a "Default Judgement" from a Court or other entity not expressly created or established under the constitution of laws of this State or the United States. It is my opinion that this filing is presumptively fraudulent pursuant to Section 51.901 of the Texas Government Code and, therefore, should be refused for filing by your office.

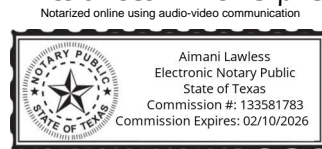
